NAHB Members and Staff Made Builders' Voices Heard at ICC Code Hearings

Dodging rain, snow and COVID in Rochester, New York, NAHB members and Construction, Codes & Standards staff again successfully argued for decent, safe and affordable housing during the first round of the International Code Council's (ICC) 2022 code development cycle.

The ICC recently held its 2022 Group B Committee Action Hearings in Rochester to consider proposed changes to the 2024 editions of the I-Codes. The Group B cycle includes the key International Residential Code (IRC) provisions related to structural design, fire safety and egress, as well as the International Existing Building Code (IEBC) and structural provisions of the International Building Code (IBC).

The four ICC code development committees considered some 800 code change proposals over nine days. The committees supported NAHB's position on 90% of the proposals for the IRC and 79% of the proposals overall. Major wins included:

- ➔ • Adding U.S. Department of Agriculture (USDA) textural soil classifications as an option for identifying soil types, in lieu of obtaining a geotechnical investigation
- ➔ • Restoring the ability to use construction-grade 6 mil polyethylene for vapor retarders under slabs-on-ground instead of costly proprietary products
- ➔ • Defeating a proposal to require all dwellings in tornado-prone areas be provided with an ICC 500-compliant storm shelter

- ➔ • Defeating a proposal to require all trusses have fully sheathed top and bottom chords or an engineered bracing design.

There were some proposals that NAHB members opposed that did get through — most notably, a set of proposals to comprehensively revise the duties of the building official, including how they review and approve alternate means and methods. Although NAHB successfully worked with proponents to modify some of the most egregious provisions, there is a concern the revisions would potentially force builders to obtain costly tests and engineering reports to demonstrate alternate materials and products comply with the intent of the code. NAHB is reviewing the committee actions and determining whether to submit public comments on proposals with unfavorable results.

ICC is accepting public comments on the committee hearing results through June 20. All submitted public comments will be heard at the ICC Group B Public Comment Hearings to be held Sept. 14-21 in Louisville, Kentucky. The hearings are open to the public, and NAHB members are encouraged to register for and attend the meetings.

In early October, following the hearings, there will be an online vote open to all validated ICC governmental voting members. NAHB will be asking members to participate in the One & Done campaign. The campaign urges each member to share NAHB's positions on code changes with at least one code official during the code development cycle.

The BIA Government Affairs Committee Meets with Commissioner



On June 2nd, Ray D'Agostino, Chairman of the Lancaster County Board of Commissioners, joined the BIA GA Committee to discuss various issues affecting our members.

The group discussed LCCD and DEP permitting, ARPA (American Rescue Plan Act) funding and how monies may be used in Lancaster County, and transportation issues and corresponding infrastructure concerns. Places2040, the County's Comprehensive Plan, was also discussed, including ways to spread its message of promoting smart growth to municipalities. Support from the County Planning Department may be helpful for many of our members' projects given its emphasis on promoting higher density development in appropriate location and their focus on developing regional comprehensive plans.

LCCD joins BIA Government Affairs Committee for Panel Discussion



New BIA Member, Lancaster County Conservation District (LCCD), joined the Government Affairs Committee meeting on April 7th. Erosion and Sedimentation (E & S) Program Department Manager, Richard Snyder and District Manager Chris Thompson were accompanied by Allyson Gibson from the Lancaster Clean Water Partners.

Questions and conversation addressed member concerns regarding review times for projects, changes in Chapter 105 with DEP, and shifting fee schedules. As a delegated authority, LCCD is required to send certain plan up to DEP for approval; the group discussed what the standard procedures were in these cases.

Of particular interest to our group was whether fees for multi-family units would be based on a per unit or per disturbed acre basis; this is still being determined and we will keep you posted! The county-wide stormwater management plan, Act 167, is in the process of being updated; whether this unites our 60 municipalities under a single plan, or allows for individual interpretation by municipality remains to be seen.

Recommendations to prepare for a smooth permitting process (i.e. no surprises!) from the LCCD included scheduling a meeting when 50% of the plan has been determined, and again, at the 90% completion mark of final design to ensure there are no obvious red flags that will hold up permitting.
