We have some exciting projects in the works for 2025

I want to start by thanking you for your continued support as we begin another year of advocating on behalf of the residential construction industry here in Lancaster County and beyond. We have some exciting projects in the works for 2025— from continuing to grow our “Building Futures” construction career fair, to undertaking a new strategic planning process, to seeking continuous improvement of staple events like the Parade of Homes. Please know that the BIA staff, Board of Directors, and Committee Members are hard at work supporting your interests and promoting your companies.

I am writing specifically to bring our 2025 BIA Raffle to your attention. If you attended the Installation Banquet in January, you heard me talk about the BIA’s budget deficit and the threat that it poses to the many programs and services we offer. The deficit is a result of a confluence of factors. We have been aggressive in trimming our budget, but we need a way to generate more revenue. The BIA Raffle is one potential solution to this problem.

The goal of the raffle is to promote our member companies while raising money for the Association. This year, we will “kick-off” the sale of raffle tickets at the Parade of Homes Gala on June

13th and will draw our winner during the Building Futures event on October 16th. The winner will receive a guaranteed \$25,000 prize to put towards a home renovation, the purchase of a new home, or the purchase of supplies and materials from one of our member companies. Proceeds from the raffle will support the BIA Foundation’s workforce development efforts.

While we will be working to promote the raffle to the public, we believe in the initial years we will need to rely on our members to support the raffle by purchasing tickets. If each BIA member company purchased or sold just 4 or 5 raffle tickets we would meet our 2025 goal of selling 1300 tickets.

This year I am asking you to partner with BIA to make the raffle a success. There are several ways you can assist, including buying tickets for yourself or your family and friends, or selling them to customers. A successful raffle in 2025 will allow us to continue advocating for your interests and promoting your companies while keeping membership dues affordable and uniform. I thank you in advance for your support.

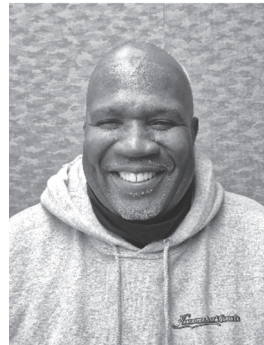

2025 International Builders' Show Boasts Record Attendance, Highlights Industry Innovation

More than 81,000 builders, remodelers, developers and other home building professionals filled the exhibit halls of the Las Vegas Convention Center as the National Association of Home Builders (NAHB) hosted the 81st NAHB International Builders' Show® (IBS), the largest annual light construction show in the world, Feb. 25-27. This marks the largest show in 17 years.

Attendees visited more than 1,800 exhibitors – including 750 new exhibitors – over 728,000 net square feet, exploring innovative building products and technology to advance the industry and enhance new homes.

“This year’s show surpassed our high expectations for attendance, exhibit space and educational opportunities,” said NAHB Chief Revenue Officer Geoff Cassidy. “Attendees saw the latest trends in home technology and resilience, and the latest advancements in building techniques.”

“There are a lot more people here this year, and they really did a good job of organizing like-vendors together to make it easier to check out the same kind of products,” said Josh Deal, a home builder at JNJ Enterprises in McKinney, Texas.

“Traffic has been incredible. We’re having great conversations, and everyone’s been super engaged,” noted Sarah Caperton, director of siding innovation and commercialization at LP Building Products.

This year also marked the 12th anniversary of Design & Construction Week® (DCW), the co-location of IBS and the National Kitchen & Bath Association’s Kitchen & Bath Industry Show. DCW drew over 124,000 attendees, and nearly 2,500 exhibitors occupied over 1.2 million net square feet of indoor and outdoor exhibits.


IBS attendees enhanced their industry knowledge by attending any of more than 120 education sessions led by experts on a wide range of industry topics, including artificial intelligence, building technology, research and trends. Two demo zones featured live demonstrations of trending topics in residential construction, allowing building professionals to learn best practices for building more durable, efficient, higher-quality homes.

Attendees also took advantage of numerous networking events throughout the week and visited The New American Home™ that showcased cutting-edge building techniques, high-performance design, and the latest

products and trends.

“There was so much to see and do, but the education was especially valuable. Each session had several really good nuggets of information that you can take and apply to different markets,” said first-time IBS attendee Ryan Darmetko, sales manager at Eastwood Homes in Charlotte, N.C. “We knew the show was going to be big and busy, but it was all very well organized and 100% worth the investment of coming.”

Next year, DCW will take place in Orlando, Feb. 17-19.

PA UCC Residential Code Update Training



On January 21, the BIA held a 2021 PA UCC Residential Code Update presented by the Pennsylvania Housing Research Center (PHRC). In accordance with the requirements of Act 45 of 1999, as amended, the Pennsylvania Uniform Construction Code (UCC) Review and Advisory Council (RAC) completed the review of the 2021 I-Codes on June 13, 2024.

Attendees met at the Eden Resort, where Pam Slusser and Darrin Wright with PHRC reviewed the PA UCC update process and timeline for implementation in 2025 in a two-part program. The first session examined the implications of transitioning to 2021 ICC base codes and discussed PA legislative and RAC amendments. Part two provided an overview of the most substantial changes between the 2018 and 2021 ICC base codes for residential construction.

Important dates:

7/13/2025: Effective date of regulations. A contract signed on or after 7/13/2025 is subject to new (2021) codes.

1/12/26: Last day of the phase-in period (last day to apply for a permit under the 2018 IRC)

NAHB Scores Key Legal, Legislative, Regulatory and Codes Victories in 2024

A Regulatory Game Changer

- The Supreme Court issued a verdict that will significantly curtail the federal agencies' regulatory power. NAHB filed a friend-of-the court brief in the case. For home building, this means that every federal agency that builders and developers must deal with – from the U.S. Department of Housing and Urban Development, to the Environmental Protection Agency, the Department of Labor, the Occupational Safety and Health Administration, and more – will have less discretion to impose new regulations that Congress did not clearly authorize.

Waters of the U.S.

- At NAHB's urging, 27 members of Congress sent a joint letter to the Environmental Protection Agency and Army Corps of Engineers calling on the agencies to adhere to the Supreme Court's Sackett ruling pertaining to the definition of "waters of the United States" (WOTUS) under the Clean Water Act. This issue was put on full display when NAHB testified before Congress on Sept. 11 that the administration's latest WOTUS interpretation further muddied the regulatory process and exacerbated the housing affordability crisis. NAHB also filed a Freedom of Information Act (FOIA) request for records relating to the regulatory definition of WOTUS and threatened a lawsuit when the agencies did not act in a transparent manner.

Workforce/Labor

- With Congress threatening to eliminate Job Corps, NAHB played a leading role in not only saving this vital workforce development program, but also ensuring that it is fully funded. This was a key ask during the June 12 NAHB Legislative Conference.
- In a key victory for NAHB members, the Eastern District of Texas on Nov. 15 issued a nationwide injunction in a coalition lawsuit NAHB filed challenging the Department of Labor's (DOL) 2024 Overtime Rule. As a result of the ruling, the salary level for determining overtime pay eligibility for salaried employees – categorized as executive, administrative or professional workers – has been lowered to the pre-2024 level of \$35,568. DOL was seeking to raise the overtime threshold to \$55,068 beginning on Jan. 1, 2025, a nearly 55% increase.

- At NAHB's urging, the Senate and House introduced the bipartisan CONSTRUCTS Act, legislation specifically geared to ease the labor shortage in the housing industry by creating a new grant program to fund residential housing construction education and skills training programs at community colleges and career and technical education schools.

Transformers

- The Department of Energy issued a final energy efficiency rule for distribution transformers that explicitly heeded NAHB's call to ensure that it would not impede the production of badly needed transformers.

Codes

- NAHB continues to pursue legislative and regulatory solutions to prevent a rule that sets the 2021 International Energy Conservation Code (IECC) as the minimum energy standard for U.S. Department of

Housing and Urban Development- and U.S. Department of Agriculture-financed new construction housing. On June 27, a House panel approved language that would prevent HUD from using federal funds to implement this rule – which is exactly what NAHB members sought in meetings with their lawmakers during the Legislative Conference. The same day, 39 lawmakers introduced a Congressional Review Act resolution of disapproval (H.J. Res. 170) to allow Congress to overturn this harmful energy codes rule.

- NAHB worked diligently to ensure the 2024 IECC features more flexibility for builders. The 2024 IECC will save builders money through more cost-effective insulation requirements. In another cost-saving measure, the electrification-ready provisions were moved to appendices.

- NAHB and the Rhode Island Builders Association have partnered to use a \$1.6 million grant from the U.S. Department of Energy to provide energy code training and educational resources to building inspectors, designers, home builders and construction trades professionals in the state. The new state code is based on the 2024 IECC.

- NAHB worked on the ASHRAE 90.1 committee to ensure that insulation and building tightness provisions for multifamily buildings remain cost-effective.

- NAHB played a key role in preventing new requirements in the International Residential Code that would force builders to hire mechanical engineers to design HVAC systems with the new A2L refrigerants for each home.

- NAHB was instrumental in defeating an International Fire Code proposal that would have required fuel gas detection systems be installed in all multifamily buildings.

Tax Policy

- With the expiration of the Tax Cuts and Jobs Act set for the end of 2025, NAHB is already laying out a strategy to fight for our priorities. NAHB engaged its members through a series of listening sessions to see which benefits were most important to advocate for in the year ahead.

- In early 2024, the House approved a tax package that would strengthen the Low-Income Housing Tax Credit, extend the 100% bonus depreciation, expand Section 179 expensing and increase the threshold for information reporting on Forms 1099-NEC and 1099-MISC. The bill did not pass the Senate.

Permitting Roadblocks

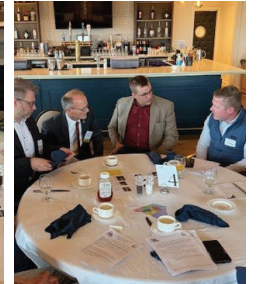
- The House approved NAHB-supported legislation that would reform and expedite the federal permitting process for home building and development projects.

Impact Fees

- In a major win for builders and developers, the Supreme Court ruled that legislation does not protect improper impact fees. NAHB and the California Building Industry Association submitted amicus briefs in the case supporting the home owner.



2025 Annual BIA Legislative Roundtable Breakfast



More than 35 BIA members met with state legislators and staffers on March 6th to discuss regulatory challenges impacting housing affordability and to review key state legislation that may warrant our support or opposition.

PA House Representatives Bryan Cutler, Keith Greiner, Tom Jones, Brett Miller, Nikki Rivera, and Dave Zimmerman attended, along with Dan Bost, staffer to Senator Chris Gebhard. This annual event provides an invaluable opportunity for industry professionals to engage directly with policymakers on pressing issues affecting new home construction.

Key topics of discussion included:

- Riparian buffer protection
- Anti-indemnification in construction contracts
- Inclusionary housing policies
- Housing density as a key part of farmland preservation
- Stormwater management

And always top of mind—

- The regulatory impact on new home prices.

BIA industry professionals remain committed to serving as a resource to state legislators in shaping sound housing policy. We appreciate all who attended and look forward to continuing these critical conversations to advocate for policies that support housing affordability and economic growth in Pennsylvania.

Secretary of Housing and Urban Development (HUD) Working to Reduce Regulatory Burdens On Housing

Secretary of Housing and Urban Development (HUD) Scott Turner said on February 27, 2025 he would work to reduce regulatory burdens to ease America's housing affordability crisis and help builders to construct more attainable, affordable housing the nation sorely needs.

In one of his first official speaking engagements after being sworn in as HUD secretary earlier this month, Turner addressed the National Association of Home Builders (NAHB) Leadership Council, which met in Las Vegas in conjunction with the 2025 International Builders' Show (IBS).

"A home is more than four walls. It's the foundation of a thriving community," said Turner. "To decrease the cost and increase the supply of affordable housing, we will terminate these unnecessary, ineffective and costly regulations."

Turner pledged to work with home builders and all interested stakeholders to find long-term solutions that make homes more affordable, spur business creation and create economic opportunity for all Americans.

"It's time we unleash the power of the private sector and the free market to build our way out of the housing affordability crisis," said Turner. "We

are going back to the drawing board to restore efficiency at HUD."

The HUD secretary further emphasized that as part of this process, "the foundation of a stable fiscal house is regulatory reform. At HUD, we are taking inventory and terminating all cumbersome regulations that make it harder for individuals and families to realize the American Dream of homeownership."

After addressing the NAHB Leadership Council, Turner participated in the IBS by touring the latest building products and innovations on the exhibit floor.

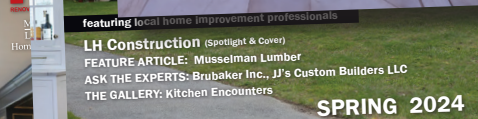
